#### 16. Funeral Service Discount Package

Visitations at our facility, staff for conducting services at church & committal service, and transporting casket to local cemetery and utility vehicle..

#### 17. Graveside Services Discount Package

### 18. Forwarding of Remains to Another Funeral Home

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of linerboard or unfinished wood.

Additional cost may apply for dressing, viewing and or holding & refrigeration mover three days.

If cremation container is provided by family subtract \$10.00 from the above.
